1 Overview

Real-world clinical data is inevitably non-uniform across multiple facilities and EHR vendors as it is not well structured for analytical purposes. CliniComp (CCI) uses an adaptive standardized approach to normalize clinical data and convert raw unstructured data into formats more suitable for analytics across disparate medical facilities and EHRs. CCI transparently consolidates clinical data into a single consistent virtual patient view based on the USCDI data set and national coding standards (e.g., SNOMED CT, LOINC, ICD-10, etc.). No modification to the underlying data structure is necessary for broad analytics across an enterprise or EHRs.





Figure 1 – Patient Record

5.4 Date Range

5.4.1 Patient Level Data – Items Without a Date Range

The admit items are recorded at admit time (registration for inpatient visits) or visit time (for ambulatory visits). There is not an end date associated with Patient-Level Data. These items do not have a date range and can be queried by searching any date or date parameter on or after the initial admit or visit time.

5.4.2 Encounter Level Data – Items with a Date

The following items have associated dates that fall within the date range of encounter start and end times. The starttime/endtime parameters can be used for querying a range of dates. To return these items in a query, the date range selected should be greater than or equal to the starttime and less than or equal to the endtime of the associated encounter. To return data for an exact date/time, specify the same date/time in "starttime" and "endtime."

5.4.3 Encounter Level Data – Items with a Date Range

The following items have onset/start times and could also have an end time. The starttime/endtime parameters can be used for querying a range of dates. To return these items in a query, the date range selected should be greater than or equal to the start/onset time and less than or equal to the endtime of the associated encounter. To return data for an exact



date/time, specify the same date/time in "starttime" and "endtime." If the item does not have an end time, the item will be returned in any query that is on or after the item onset/start time.

5.7 Full Patient Query

6 Terms of Use

6.1 API Usage Terms & Conditions

By accessing or using our APIs, you are agreeing to the terms below. If there is a conflict between these terms and additional terms provided by us, the additional terms will control for that conflict. Collectively, we refer to the terms below, any additional terms, terms within the accompanying API documentation, and any applicable policies and guidelines as the "Terms." You agree to comply with the Terms and that the Terms control your relationship with us. So please read all the Terms carefully.

Under the Terms (please refer to 45 CFR § 170.404 overall with notes below referencing specific sections of the regulation), "CliniComp" means CliniComp International, Inc., a Delaware corporation with its principal place of business at 9655 Towne Centre Drive, San Diego, California, U.S.A. We may refer to "CliniComp" as "we", "our", or "us" in the Terms. Except as exigent circumstances require, prior to making changes to our certified API technology or to the terms and conditions thereof, we will provide notice and a reasonable opportunity for API Information Sources and API Users to update their applications to preserve compatibility with our certified API technology and to comply with applicable terms and conditions (section (a) 4 (iii)).

6.2 Account and Registration

6.2.1 Accepting the Terms

You may not use the APIs and may not accept the Terms if (a) you are not of legal age to form a binding contract with CliniComp, or (b) you are a person barred from using or receiving the APIs under the applicable laws of the United States or other countries including the country in which you are resident or from which you use the APIs.

6.4.1 Permitted Access

6.5 API Clients

6.5.1 API Clients and Monitoring

The APIs are designed to help you enhance CliniComp's client applications. YOU AGREE THAT CLINICOMP MAY MONITOR USE OF THE APIS TO ENSURE QUALITY, IMPROVE CLINICOMP PRODUCTS AND SERVICES, AND VERIFY YOUR COMPLIANCE WITH THE TERMS. This monitoring may include CliniComp accessing and using your API Client to identify security issues that could affect CliniComp or its users. You will not interfere with this monitoring. CliniComp may use any technical means to overcome such interference. 6.5.3 Ownership

6.6 Prohibitions and Confidentiality

6.6.1 API Prohibitions

When using the APIs, you may not (or allow those acting on your behalf to):

You agree to display any attribution(s) required by CliniComp as described in the documentation for the API. CliniComp hereby grants to you a nontransferable, non



sublicensable, nonexclusive license while the Terms are in effect to display our Brand Features for the purpose of promoting or advertising that you use the APIs. You must only use our Brand Features in accordance with the Terms and for the purpose of fulfilling your obligations under this Section. You understand and agree that we have the sole discretion to determine whether your attribution(s) and use of our Brand Features are in accordance with the above requirements and guidelines.

6.8.3 Publicity

You will not make any statement regarding your use of an API which suggests partnership with, sponsorship by, or endorsement by CliniComp without our prior written approval.

6.9 Termination

6.9.1 Termination

You may stop using our APIs at any time with prior notice as described in your user agreement with CliniComp | EHR. Further, upon termination, cease your use of the applicable APIs. CliniComp reserves the right to amend the Terms upon notice to you and to terminate the Terms with you or discontinue the APIs or any portion or feature or your access thereto for any reason and at any time without liability or other obligation to you.

6.9.2 Your Obligations Post-Termination

Upon any termination of the Terms or discontinuation of your access to an API, you will immediately stop using the API, cease all use of the CliniComp Brand Features, and delete any cached or stored content that was permitted by the cache header under the section 6.7 on Content. CliniComp may independently communicate with any account owner whose account(s) are associated with your API Client and developer credentials to provide notice of the termination of your right to use an API. In addition, the obligations of Confidentiality contained in section 6.6 and Indemnification contained in section 6.10.2, as well as the Limitation of Liability contained in section 6.10.1, will survive the termination of the Terms.

6.10 Liability & Indemnification

6.10.1 Limitation of Liability

When permitted by law, CliniComp, and CliniComp's suppliers and distributors, will not be responsible for loss of profits, revenues, or data, financial losses, or indirect, special, consequential, exemplary, or punitive damages.

To the extent permitted by law, the total liability of CliniComp, and its suppliers and distributors, for any claim under the terms, including for any implies warranties, is limited to the amount you paid us to use the applicable API's (or, if we choose, to supplying you the API's again) during the 6 months prior to the event giving rise to the liability.



In all cases, CliniComp, and its suppliers and distributors, will not be liable for any expense, loss, or damage that is not reasonably foreseeable.

6.10.2 Indemnification

Unless prohibited by applicable law, if you are a business, you will defend, indemnify, and hold harmless CliniComp, and its affiliates, directors, officers, employees, and users, against all liabilities, damages, losses, costs, fees (including legal fees), and expenses relating to any allegation or third-party legal proceeding to the extent arising from:

- your misuse or your end user's misuse of the APIs;
- your violation or your end user's violation of the Terms; or
- any content or data routed into or used with the APIs by you, those acting on your behalf, or your end- users.

Appendix – CliniComp, Intl., API Terms Of Use

These CliniComp API Terms of Use form an agreement (the "<u>Agreement</u>") between CLINICOMP, Intl. ("<u>CliniComp</u>"), and you (the "<u>Developer</u>"). By accessing or using any CliniComp API, you are agreeing to be bound by the terms of this Agreement.

BACKGROUND. CliniComp provides an electronic healthcare record software ("<u>CliniComp</u>, <u>Intl.</u>"). Developer provides products and services (the "Developer Applications") to developer's customers, some of which are also CliniComp customers. Developer desires to obtain access and make calls to CliniComp APIs. CliniComp is willing to provide such access subject to the terms and conditions herein.

AGREEMENT. In consideration of the foregoing and the mutual promises made herein, the parties agree as follows.

- <u>Acceptance of Terms.</u> You are deemed to be entering into this Agreement and accept all
 of its terms if you access or use any CliniComp API. If you are using the CliniComp APIs
 on behalf of an entity, you represent and warrant that you have authority to bind that
 party to this Agreement, and you are doing so on behalf of both you and that entity.
 Notwithstanding the foregoing, the terms of this Agreement shall be superseded by any
 conflicting or additional terms set forth in a separate written agreement that you or that
 entity specifically enter into with CliniComp regarding the use of CliniComp APIs.
- 2. <u>Certain Defined Terms.</u> As referenced in the Agreement, the following terms are defined as hereinafter set forth:
 - A. "<u>Developer Data</u>" means all data created by Developer or a Developer Application.
 - B. "<u>CliniComp API</u>" means any form of machine accessible application programming interface provided by CliniComp that provides access to or enables interaction with a CliniComp service, and includes all associated documentation, tools, and sample code, and executables of any of the foregoing.
 - C. "<u>CliniComp Data</u>" means all data created by CliniComp products, whether or not derived from Provider Data.
 - D. "<u>Providers</u>" means the providers of medical services for whom Developer will provide Developer Applications that interoperate through a CliniComp API hereunder.
 - E. "<u>Provider Data</u>" means, as to a particular Provider, data created by that Provider that is stored in or accessible from a CliniComp product.
- 3. <u>Grant of License</u>. Subject to the terms in this Agreement, CliniComp hereby grants Developer a limited, non-exclusive, non-assignable, non-transferable, revocable license to use and make calls to certain CliniComp APIs provided for general access to the developer community for the sole purpose of developing, testing, and supporting



elements of the Developer Application that interface with and interoperate with a CliniComp product.

- 4. <u>Restrictions on Use.</u> In addition to any other limitations set forth in this Agreement or imposed by law (per 45 CFR § 170.404 (a) (2) (ii)), Developer will not:
 - A. Use any CliniComp API in a way that could impair, harm or damage CliniComp, any CliniComp service or application, or any other person's use of a CliniComp API, service or application, or that exceeds the API use restrictions set forth in any documentation, if applicable;
 - B. Use any CliniComp API to disrupt, interfere with, or attempt to gain unauthorized access to services, servers, or networks connected to, or accessible through, any CliniComp API, including those of CliniComp or any Provider;
 - C. Reverse engineer, decompile, or disassemble any CliniComp API or software product, or redistribute, resell or sublicense access to any portion of a CliniComp product;
 - D. Use any CliniComp API in a way that threatens the integrity, performance or reliability of any CliniComp API, including performance or stress testing, or in any manner that works around any technical limitations incorporated into a CliniComp API;
 - E. Request from a CliniComp API any Provider Data that is not required for the Developer Application to operate in accordance with its documentation and the direction of the applicable Provider, or for which it does not have a valid grant of access from the applicable Provider;
 - F. Import or write any personally identifiable information or protected health information (as such terms are defined by any applicable law) or production data of any sort into a testing or non-production environment established by CliniComp for integration testing or similar use by developers;
 - G. G. Resell, sublicense or, except as expressly contemplated in this Agreement, distribute any Provider Data or CliniComp Data;
 - H. Share any access credentials provided by CliniComp with any third party, or use any such credentials for a Provider or practice other than the one identified by CliniComp for such purpose;
 - I. Falsify or alter any identifier assigned to a Developer Application, or otherwise obscure or alter the source of queries coming from a Developer Application; or
 - J. Use any CliniComp API or any CliniComp Data in a manner that violates any applicable law or third party right, including federal and state laws pertaining to the privacy and protection of personal health information and personally identifiable information.

- 5. <u>Promotion.</u> Developer and CliniComp shall each be permitted to disclose to Providers the existence of this Agreement and that Developer has received CliniComp's limited authorization for the Developer Application to interface and interoperate with the API. Neither party shall make any misleading statements regarding the other's products or services, including any inaccurate description or unauthorized warranty relating to the other's offerings, nor any statement which suggests a partnership, sponsorship, or endorsement of the other party. Each party hereby grants to the other a limited, non-exclusive, non-assignable, nontransferable, revocable right to use its name and logo and the name and logo of the interfacing CliniComp API and Developer Application, as applicable (collectively, the "Marks") during the Term and solely as described in the immediately preceding sentence. All such use of the Marks shall inure only to the benefit of the owner thereof and, except as expressly provided herein, neither party is granting the other any right, title or interest in its or its affiliates' Marks.
- 6. <u>Support and Maintenance.</u> Per 45 CFR § 170.404 (a) (4) (iii), CliniComp will use commercially reasonable efforts to provide Developer with access to current documentation for the CliniComp APIs. CliniComp shall not be required to provide training or other support relating to Developer's use of any CliniComp API or CliniComp Data, and CliniComp has no obligation to update or modify the CliniComp APIs.
- 7. <u>Modifications; Deprecation.</u> Developer acknowledges and agrees that CliniComp may, in its sole discretion, update or modify all or any portion of the CliniComp APIs and that such updates or modifications may remove or restrict previously existing functionality or require Developer to update or modify its Developer Applications.
- 8. <u>Confidentiality.</u> During the Term, Developer may obtain access to information of CliniComp that is of a confidential or proprietary nature. Such information is collectively referred to as "CliniComp Information." Developer agrees to not use such CliniComp Information except as expressly contemplated by this Agreement, and to not disclose it to any third party without CliniComp's prior written consent. Notwithstanding the foregoing, disclosure is permitted to the extent required by law or court order, provided Developer first gives reasonable notice to CliniComp (unless prohibited by law or court order) and, if requested, provides reasonable assistance in obtaining a protective order. CliniComp Information does not include information that Developer independently develops (without use of any other CliniComp Information), that was rightfully given to Developer by a third party without any conflicting obligation of confidentiality, or that becomes public through no fault of Developer.
- 9. <u>Ownership Rights.</u> Except as expressly provided for in this Agreement, CliniComp retains all right, title and interest in the CliniComp APIs, the CliniComp Data, the CliniComp Information, and all of CliniComp's other intellectual property, data and technology, and Developer retains all right, title and interest in the Developer Application, the Developer Data and all of its other intellectual property, data and technology. Notwithstanding anything to the contrary herein, CliniComp shall have the right, without limitation or



obligation to Developer, to use and commercialize any feedback provided by Developer to CliniComp about the CliniComp APIs.

- <u>Non-exclusive</u>. This Agreement is non-exclusive, and nothing herein shall prohibit CliniComp from developing any product or service, including those that may be similar to or competitive with the Developer Application (per 45 CFR § 170.404 (a) (4) (ii) (B) 3).
- 11. <u>Audit Right.</u> Developer agrees that CliniComp may monitor use of the CliniComp APIs to ensure compliance with the terms of this Agreement, and Developer will not take any action to interfere with such monitoring. In addition, CliniComp shall be permitted, upon reasonable advance notice and during regular business hours, to inspect and audit the files and records of Developer as necessary to verify compliance with this Agreement, and Developer shall cooperate with all reasonable requests in conducting any such audit.
- 12. Term and Termination; Suspension. The term of this Agreement shall commence on the Effective Date of registration and will continue until terminated in one of the following manners. Developer may terminate this Agreement upon written notice at any time. CliniComp may terminate this Agreement and Developer's use of all CliniComp API's (A) for any reason, upon ninety (90) days' prior written notice, (B) on thirty (30) days' prior written notice in the event of a breach by Developer of any term of this Agreement that is capable of cure, unless such breach has been cured (as determined by CliniComp) within such thirty (30) day period; or (C) immediately in the event of a material breach by Developer that is not capable of cure, including any breach of Section 4 of this agreement. In addition, if CliniComp determines, in its sole discretion, that Developer's use of the CliniComp API is causing an interruption or degradation in the performance of any CliniComp API, then CliniComp may, without liability to Developer or any other party, temporarily suspend Developer's access to the CliniComp APIs until such time as CliniComp is reasonably assured that such interruption or degradation shall no longer occur.
- 13. <u>Effect of Termination; Survival.</u> Immediately upon the termination of this Agreement for any reason, (A) CliniComp shall cease all use of Developer's Marks (e.g. trademarks, tradename and the like), (B) Developer shall cease all use of the CliniComp APIs, the CliniComp Data, the CliniComp Information, and CliniComp's Marks, and (C) all licenses granted in this Agreement shall terminate. Notwithstanding the foregoing, each provision of this Agreement that by its nature is intended to apply beyond its term will survive its termination, including this Section 13 and each of Sections 8, 9, and 14 through 17, inclusive.

FOLLOWING ANY TERMINATION OR EXPIRATION OF THIS AGREEMENT, DEVELOPER SHALL NOT USE OR RETAIN ANY PROVIDER DATA OBTAINED THROUGH A CLINICOMP API WITHOUT THE EXPRESS PERMISSION, UNDER SEPARATE AGREEMENT, FROM EACH APPLICABLE PROVIDER. UPON REQUEST BY CLINICOMP, DEVELOPER SHALL CERTIFY IN WRITING ITS COMPLIANCE WITH SUCH RESTRICTION.

- 14. Indemnification. Developer shall indemnify and hold CliniComp, its affiliates, and each of their respective directors, officers, employees and agents, together with each of their respective successors and assigns, harmless against any and all claims, demands, liabilities, damages, losses, costs, fees (including legal fees) and expenses, of any type whatsoever relating to a third party claim arising out of (A) Developer's use of a CliniComp API or breach of this Agreement, (B) any data or content routed by Developer or its customers through the Developer Application, or (C) any claim that the Developer Application infringes the patent, copyright, trademark or other intellectual property right of a third party (except to the extent such claim is based on the CliniComp API). Any claim for indemnification hereunder shall be made promptly following the event giving rise thereto, provided that any failure or delay in providing such notice shall not relieve Developer of its obligations except to the extent actually prejudiced thereby. In the event of any claim for indemnity hereunder, Developer shall, if requested by CliniComp in writing, promptly assume the defense thereof, at its own expense, with counsel reasonably acceptable to CliniComp. Regardless of which party is defending, each party shall cooperate with the other as reasonably requested in connection the indemnified matter, shall keep the other reasonably apprised of the status thereof, and shall not enter into any settlement or compromise that creates any obligation or liability or admits any wrongdoing on behalf of the other party without the consent of such other party, not to be unreasonably withheld, conditioned or delayed.
- 15. Disclaimer and Limitation of Liability.
 - A. EXCEPT AS EXPRESSLY SET FORTH HEREIN, CLINICOMP MAKES NO REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, REGARDING THE SUBJECT MATTER OF THIS AGREEMENT, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT. SPECIFICALLY, CLINICOMP MAKES NO WARRANTY THAT THE CLINICOMP APIS WILL FUNCTION AS INTENDED OR THAT THEY WILL BE AVAILABLE OR FREE FROM BUGS OR OTHERWISE MEET DEVELOPER'S NEEDS. THE CLINICOMP APIS ARE PROVIDED "AS-IS."
 - B. NOTWITHSTANDING ANYTHING ELSE IN THIS AGREEMENT OR OTHERWISE, THE TOTAL LIABILITY OF CLINICOMP AND ITS AFFILIATES UNDER THIS AGREEMENT SHALL BE LIMITED TO FIFTY DOLLARS (\$50). IN NO EVENT WILL CLINICOMP OR ITS AFFILIATES BE LIABLE TO DEVELOPER OR ITS AFFILIATES UNDER THIS AGREEMENT FOR ANY OTHER DAMAGES, UNDER ANY LEGAL THEORY, WHETHER DIRECT OR INDIRECT, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR OTHERWISE, INCLUDING LOST PROFITS, DATA OR BUSINESS OPPORTUNITY. THE FOREGOING SHALL APPLY EVEN IF CLINICOMP OR SUCH AFFILIATE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND EVEN IF A LIMITED REMEDY SET FORTH IN THIS AGREEMENT FAILS OF ITS ESSENTIAL PURPOSE.
- 16. <u>Dispute Resolution.</u> Any controversy or claim arising out of or relating to this Agreement shall be settled solely by binding arbitration administered by the American



Arbitration Association in accordance with its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. Claims shall be heard by a single arbitrator. The place of arbitration shall be State of Delaware. The arbitration shall be governed by the laws of the State of Delaware (other than choice of law principles thereof). The prevailing party shall be entitled to an award of reasonable attorney fees. Except as may be required by law, neither a party nor an arbitrator may disclose the existence, content, or results of any arbitration hereunder without the prior written consent of both parties. Notwithstanding the foregoing, each party agrees that the other shall be entitled to specific performance of the other's obligations under Sections 4 or 8 of this agreement and without any requirement to post a bond or prove damages.

- 17. General Provisions.
 - A. <u>Subsidiaries and affiliates.</u> Developer agrees that certain CliniComp APIs or portions thereof may be provided by subsidiaries or affiliates of CliniComp and, to the extent so provided, this Agreement also governs the provision thereof and the relationship between Developer and such entities.
 - B. <u>Assignment.</u> Developer may not assign or delegate this Agreement, in whole or in part, without the prior written consent of CliniComp. CliniComp may assign this Agreement without restriction in the event of any sale of all or substantially all of its assets or any merger, sale of stock, or similar transaction. Subject to this Section 17.B, this Agreement shall inure to the benefit of and shall be binding upon the parties hereto and any permitted successor or assign.
 - C. <u>Severability</u>. If any provision of this Agreement is determined to be unenforceable, the enforceability of the remaining provisions will not in any way be affected or impaired, and the parties shall substitute an enforceable provision for the affected provision which approximates the intent and economic effect of the affected provision as closely as possible.
 - D. <u>Relationship of the Parties.</u> The parties hereto are each independent contractors of the other, and nothing contained herein shall be construed as creating any partnership, joint venture, or other form of joint enterprise between the parties. Except for the indemnitees described in Section 14, there are no third-party beneficiaries to this Agreement.
 - E. <u>Construction; Certain Definitions.</u> The parties agree that (i) "including" and other words or phrases of inclusion shall be regarded as nonexclusive and equivalent to the terms "including, but not limited to," (ii) "person" means, as applicable, an individual person, corporation, limited liability company, joint venture, or unincorporated organization, as well as any governmental authority, and (iii) "affiliate" means, with respect to any person, any other person that controls, is controlled by, or is under common control with, such person. Whenever appropriate, singular forms used herein shall be deemed to include the plural and



plural forms used herein shall be deemed to include the singular. The captions and other headings contained in this Agreement are inserted for convenience of reference only and shall not affect the interpretation or meaning of this Agreement. Each party has had the chance to consult with counsel regarding this Agreement and accordingly agrees that in the event any provision hereof is deemed to be ambiguous, no presumption shall arise for or against either party because it or its representatives were the drafters thereof.

- F. <u>Amendment and Waiver.</u> In order to be binding, any amendment or modification of any of the provisions of this Agreement must be in writing and signed by a duly authorized representative of each party. In the event of a conflict between the terms hereof and any such written modification, the document later in time shall prevail. Any waiver of a right set forth in this Agreement shall only be effective if made in writing by the party against whom it is to be enforced. The waiver of any breach or delay in enforcing any provision of this Agreement shall not operate as a waiver of any subsequent breach or right to enforce the same.
- G. <u>Notices.</u> Any notice required or permitted under this Agreement shall be in writing and shall be deemed to have been delivered: (i) upon personal delivery; (ii) three (3) business days after registered certified mailing, postage prepaid and return receipt requested; (iii) one (1) business day after being sent by nationally recognized express courier for next business day delivery, costs prepaid, or (iv) on the date sent by PDF attached to an electronic mail message if sent before 5pm on a business day at the recipient's location and, if not, on the next business day. Notices sent to CliniComp shall be addressed to its primary business address. Notices sent to Developer may be addressed to any address, including email address, that has been provided by Developer for registration or use of a CliniComp API and has not been rescinded.
- H. <u>Counterparts; Signatures.</u> This Agreement may be executed in one or more counterparts, all of which together constitute the same agreement. Signatures delivered by facsimile, email or other electronic means shall have the same effect as original signatures.
- Entire Agreement. This Agreement (including all exhibits, addendums, and schedules hereto, which are hereby incorporated by reference) comprises the entire understanding and agreement of the parties concerning the subject matter hereof, and supersedes all prior writings, discussions, representations and understandings with respect thereto.
- J. <u>Governing Law</u>. These terms and conditions and the transactions contemplated hereby shall be governed by, and construed and interpreted in accordance with, the laws of the State of Delaware, U.S.A., without regard to the choice-of-law principles thereof.
